The applicant must be a registered member of the Council during the Financial Year 2021-2022 for being eligible for submission of application for Export Awards, and continue to be a Member of the Council.

The Council shall not entertain/consider "Third Party" Exports for Awards. "Third Party" Exports shall mean exports executed by an Exporter or Manufacturer for and on behalf of another Exporter(s), wherein the "First Party" will not come in the picture, and all the export documents will bear the name, address and other details whereof, of the "Third Party";

The Applicant shall forward the application for Export Awards in the format hereto attached;

The Applicant should submit to the Council separate Application for each product;

An "Award Processing Fee" of Rs.5,000/- (Rupees Five thousand only) is required to be remitted by the Applicant, together with each Application. The processing fees will not be refundable.

The Applicant is required to submit to the Council a Chartered Accountant's Certificate, duly certifying
