This is further to our circular number IOPEPC/252/2022-23 dated  $25^{th}$  January 2023. We would like to inform you that the date of our Virtual Buyer Seller Meet (VBSM) with Thailand which was scheduled to be held on  $20^{th}$  February 2023 is deferred and will now be held on  $23^{rd}$  March 2023.

The change in date is because it was clashing with the date of Gulfood 2023 being held at Dubai during  $20^{th} - 24^{th}$  February 2023.
