We are happy to inform you that in order to help the companies to promote their business, Council has decided to provide nicely built-up stalls admeasuring 9 sq. mtr during our IGOC 2022 being held **04th - 06th November, 2022** at **Hotel Hyatt Regency, Deira, Dubai**.

IGOC 2022 will be attended not only by the exporter members but also other stakeholders of Oilseeds & Oils Industry and Trade including international delegates and speakers.

It would be a wonderful opportunity for delegates to interact with Oilseeds and oils stakeholders who are decision makers (Owners, Managing Directors, Chief Executive Officers etc.) in their respective companies under one roof and develop your business relationships with the participants from all over the world. - 2) The application would be treated valid only if it is accompanied with nonrefundable charges for stall (**Rs 2,50,000 plus GST**) in favour of Indian Oilseeds and Produce Export Promotion Council payable at Mumbai, to reach IOPEPC office on or before **30th September, 2022**.
- 3) One full page colour advertisement on complimentary basis will be published in **Souvenir 2022**.
- 4) Only two persons from the company would be allowed to stand at the stall and would be given 1 room on twin sharing basis.
- 5) The company would be allowed to display standees and video without sound at the stall. They can also display and distribute their brochures/leaflets during the Trade Meet.
- 6) IOPEPC reserves all rights unconditionally to act, accept or reject the application.
- 7) The fees of the selected participants will be retained by the Council on non-refundable basis.
- 8) The fees of the applicants who are not selected would be refunded without any interest payable.
- 9) The allocation and location of stall would be at the sole discretion of the Council.
- 10) IOPEPC reserves all rights unconditionally to withdraw the provision to provide stalls and in that case the stall charges would be refunded without any interest payable.
