The given platform shall be available at the <u>https://dgft.gov.in</u>.

The objective of the platform is to provide an electronic, contact-less single window for the RCMC/RC related processes including Application for fresh/amendment/renewal of RCMC/RC. Please note that the members who have IEC Code and require RCMC need to apply for renewal through DGFT portal, rest of the members can apply for renewal directly to IOPEPC.

Those applying for renewal of membership directly to IOPEPC can pay fees by NEFT. The **Covering letter** must be accompanied with the copy of payment receipt/UTR No. along with the date of NEFT issued by the bank.

Please note that in case, copy of payment receipt / UTR No. (Along with the date of NEFT) is not provided, the Council would not be able to ascertain the payment from whom the fees have been received.
