As you all are aware The General Administration of Customs of China (GACC) had announced Decree Order No. 248 in April 2021 (Regulations of the People's Republic of China on the Registration and Administration of Overseas Manufacturers of Imported Food". As per regulations all overseas food manufacturers, processors, and storage facilities are required to be registered with GACC.

For products within 19 categories :

6000-7000 USD for a sub-category under a general category.

(For example, there are two sub categories under edible oil and oilseeds, i.e. oilseeds and edible vegetable oil, the price USD 6000-7000 will be charged for all products under one sub-category. If the enterprises have multiple manufacturing addresses, each manufacturing address would be charged separately.

ii. For products outside 19 categories:

3000-3500 USD for a sub-category under a general category.

As informed by our Mission, it may be noted that **these agencies are neither empanelled nor recommended by the Embassy** in any way and this list has only been compiled for information.

Enterprises inclined to avail services of these agencies may like to **check all information** regarding the agency and personally negotiate on the prices quoted by them.
